PROGRADAL CT WORK AND PRIORITIES FOR 1980-1981

Introduction

The work programe presented in this document represents the revised version of the programs of work and priorities for 1980-1981 previously contained in document T/C 1.14/TECO/41/Rev.1 of 16 November 1979. The revision has three objectives, namely, firstly to reflect a more realistic appraisal of the prospects of obtaining funds, secondly to reflect a hard core of priorities in the Lagos Plan of Accien - considerably reduced in size and of greater credibility - and thirdly to take account of bottlenecks (e.g. long periods required to secure the services of consultants) which are beyond the power of the secretariat to remove Hence each project is concerned not only with the various stages but also with the length of time which experience indicates would be required for the completion of one stage and the commencement of another.

The basic assumptions of the work programme presented are the need for an increasing measure of economic self-reliance and for the installation, within the countries of the region individually and collectively, of the components of an autonomous and self-sustaining engine of growth and diversification, capable of being directed to meet one or more of several objectives of socio-economic policy. These would include accelerated and diversified growth to meet the needs of the mass of the people, the widespread development of capabilities for generating and retaining real income, the reduction of unemployment, and the moderation of the present pattern of urban growth and poverty.

For a better understanding of the substance of the programme, a number of the design characteristics of the programme should be clearly understood. One of these is the close relationship between projects in the five standard categories of classification of "final output", with the result that the same subject appears under (a) ""echnical advisory services to countries and territories", (b) "Studies" and occasionally under (c) "Collection and dissemination of information" and under (d) "Conferences, meetings, seminars, training courses, and expert working groups" The effect of this is to reinforce the thrust of a programme or supprogramme.

A second design characteristic is the broad classification of each programme wherever applicable into (i) General programme, (ii) Regional programme, (iii) Subregional programme and (iv) Interregional programme - an exercise necessitated by the need to show the relationship among projects carried out at the MULPOC level and those at the Centre.

A third characteristic is the rationalization of programme presentation, for example under International Trade and Finance, by drawing a distinction between intra-African trade and finance and external trade and domestic trade and trade with non-African countries.

A fourth design characteristic is that of subject area presentation. Projects appearing in different programmes are assembled together for easy comprehension under a single heading and suitably located, e.g. Least developed countries under Socio-economic research and planning, Economic co-operation among developing regions under Promotion of economic co-operation and integration.

A fifth design characteristic is the recognition of policy and planning aspects, manpower aspects and institution building aspects in several programmes. Of many important institutions proposed, two deserve special notice: The African Institute for Policy Analysis and Perspective Studies (Project 9.501.04) and the Centre for Consulting Engineering and Hanagement Services (project 9.333.01(a)(i)).

A sixth additional characteristic, which is also an improvement in the work programme presentation aimed at facilitating programme performance, monitoring, reporting and evaluation is the method of identifying final output (as distinct from intermediate output) as either "report", "survey", "guidelines", "manual" or "handbook" instead of synonyms such as "study", "publication", "research paper", etc. Therever possible, an effort has been made to ensure that mention is made of the cutput category, the primary user, the content of the final output and the date by which it is expected to be made available to its primary users.

This new approach is in keeping with the ongoing system-wide development of the programme planning and budgeting system of the United Nations, which includes programme performance, monitoring, reporting and evaluation.

The underlying strategy of the programme is based on the New International Economic Order spelled out in terms of the socio-economic characteristics and problems of the region. The programme reflects the need for rapid, simultaneous and interlinked advance on several strategic points and takes into account the present low level of self-reliance and of self-sustaining growth and structural diversification characteristic of most countries of the region. This level is, in part, due to the fact that of the 47 independent States in the region 26 are estimated to have a population of 5 million or less and only two a population of over 30 million. Twenty of the 29 least developed countries in the developing world are located in the region. The dominance of subsistence production is well known and so is the predominance of only one or two primary commodities in national export.

Largely because of the worsening situation of balance of payments and its intensification as regards food, energy, spare parts., the work programme also reflects the rejection of dependence on one or two products and therefore the need to establish dynamic expanding economies on a much broader basis of the region's raw materials, factor inputs and markets.

The continuity of the evolution of perceptions, concepts, strategies and programmes of the ECA since the adoption of the Revised framework of principles for the implementation of the new international economic order in Africa 1/ has been reflected in its work programmes and medium-term plans and in structural changes in the Commission's organs and secretariat.

Work programmes of the Natural Resources Division and of the Joint ECA/FAO Division of Agriculture reflect continuing efforts to expand African capabilities in determining the natural resources/raw materials base of economic growth, whilst the work programmes and activities in agriculture and industry concentrate on the process of conversion of raw materials into semi-finished and finished products to raise living levels of mass of African populations as well as to lay the foundations for an increasing measure for self-reliance and self-sustainment. The supply of real factor inputs (skilled and semi-skilled manpower for entrepreneurial functions, management, production, marketing and distribution, research and development; technologies; equipment; raw materials; institutional services and so on) whilst they primarily concern work programmes in public administration, management and manpower, the integration of women in development, and science and technology and of associated institutions of ECA such as the Regional Centre for Engineering Design and Manufacturing, the African Regional Centre for Technology are spread theoughout other work programmes. Similarly, whilst the spatial aspects of economic growth and development are most obvious in the work programmes and activities in human settlements, they are more generally reflected in components of the secretariat's work on integrated rural development dispersed in several work programmes.

The reform of domestic trade, hitherto at the periphery of the secretariat's work, is now expected to more to a position where it will effectively complement the work programme on intra-African and extra-African trade and on the promotion of intra-African economic co-operation.

Institution building at the multinational and regional levels continues although the scope and role of this factor appears to be still underrated particularly where its benefits, although believed to be substantial, have not been directly or indirectly measured.

The relative neglect of population in economic calculations and public policy making, hitherto hindered by macro-financial approaches to economic growth, is now beginning to be repaired as population studies are strengthened and as steps are taken to incorporate the results more clearly in planning techniques, along with factor inputs, material balances, spatial concepts and linkage effects. Apart from general projections, the special studies projects in work programmes in socio-economic research and planning continue to throw light on major problems confronting socio-economic policy-making and planning.

A particular component of the expanding work on statistics is the African Household Surveys Capability Programme whose value is perhaps as yet not fully grasped. The surveys are expected to provide the means of evaluating, along with other studies, the levels, types and scope of poverty; the impact of economic growth policies, programmes and projects: gaining insights into basic needs and changing demand patterns pictures, resource flows and use; and yielding information and data requirements for planned linkages, employment trends and the means of devising more realistic socio-economic indicators. Together with programmes in environmental protection and development and in social development the surveys will contribute to evaluations of the quality of life of segments of the population.

Little need be said of the recognition which continues to be given to transport and communications in a region of such size and such widely dispersed concentrations of population, with 50 independent States, many of them land-locked or island States effectively isolated from each other.
