RULES FOR THE APPOINTMENT OF THE STAFF OF THE CENTRAL AFRICAN MINERAL RESCURCES DEVELOPMENT CENTRE

The Exercise of the powers conferred upon the Governing Council by paragraph (3) of Article 5 of the Agreement concerning the establishment of the Central African Mineral Resources Development Centre at Brazzaville in the People's Republic of Congo (hereinafter referred to as "the Centre",) the Governing Council hereby makes the following rules:

APPOINTMENT

- 1. Applications for appointment to all posts in the Centre other than that of the Director General of the Centre, shall be made to the Director General.
- 2. The Director General shall consider all applications received by him for appointment to a professional post in the Centre and shall make his recommendation there on to the Governing Council for its approval. The approval of the Governing Council may be obtained either at a meeting of the Governing Council or through correspondence with its members.

- 3. The recommendations of the Director General made under Rule two of these rules shall be approved by a majority vote of the members present at a meeting of the Governing Council. When approval is sought by correspondence, approval shall be by the majority view of the members who convey their approval in writing to the Director General within two months.
- 4. Subject to the directions of the Governing Council applications for appointment to a post other than a professional post in the centre shall be judged on their merit by the Director General.

TERMINATION OF APPOINTMENT

5. When for any good cause the Director General is of the opinion that the services of a person holding a professional post in the Centre should

be terminated, he shall make his recommendations for the Governing Council which shall decide on the case by a majority vote of the members present.

6. Subject to the directions of the Governing Council, when for any good cause the Director General is of the opinion that the services of a person holding a post other than a professional post in the Centre should be terminated, the Director General shall be entitled to terminate such services.

TERMS AND CONDITIONS OF SERVICE

7. The terms and conditions of service of all persons rendering service to the centre shall be determined by the Governing Council on the undertaking that in the case of persons rendering such services within the context of technical assistance from the United Nations, Governments, organizations, and institutions, the Council's determination shall be consistent with the terms of such technical assistance.

VACANCIES

8. Subject to the directions of the Governing Council, the Director General shall prepare and cause to the following notices of all vacant posts in the Centre.

AMENDMENTS

9. These Rules may from time to time be amended by the Governing Council.
