

RULES CONCERNING THE APPOINTMENT OF THE DIRECTOR GENERAL OF THE CENTRAL AFRICAN MINERAL RESOURCES DEVELOPMENT CENTRE, BRAZZAVILLE PEOPLE'S REPUBLIC OF CONGO RULES CONCERNING THE APPOINTMENT OF THE DIRECTOR GENERAL OF THE CENTRAL AFRICAN MINERAL RESOURCES DEVELOPMENT CENTRE, BRAZZAVILLE PEOPLE'S REPUBLIC OF COMO

IN EXERCISE of the powers conferred upon the Governing Council by subparagraph (f) of paragraph 3 of Article 5 of the Agreement concerning the establishment of the Central African Mineral Resources Development Centre at Brazzaville in the People's Republic of Congo (hereinafter referred to as "the Centre ",) the Governing Council hereby makes the following rules:

APPOINTMENT

1. Applications for appointment to the post of Director-General of the Centre shall be made to the Executive Secretary of the United Mations Economic Commission for Africa.

2. The Executive Secretary of the United Nations Sconomic Commission for Africa shall cause the applications received by him to be evaluated and shall submit such applications and the evaluations thereon for consideration by the Chairman, Vice Chairman and Rapporteur General of the Governing Council.

3. The Chairman, Vice Chairman and Rapporteur General of the General Council shall make their recommendations on the applications made to the Executive Secretary of the United Nations Economic Commission for Africa having regard to the evaluations thereon caused to have been by the said Executive Secretary, to the Governing Council for its approval either at a meeting of the Governing Council or through correspondence with its members. TERMINATION OF APPOINTMENT

4. When for good cause a member of the Governing Council is of the opinion that the services of the person holding the post of Director-General of the Centre should be terminated, he shall submit a recommendation to that effect in writing to the Chairman of the Governing Council. That recommendation shall be considered at a meeting of the Governing Council and decided by a simple majority vote of all the members of the Council.

TERMS AND CONDITIONS OF SERVICE

5. The terms and conditions of service of the Director-General of the Centre shall be determined by the Governing Council.

VACANCY

6. When a vacancy occurs in the post of the Director-General of the Gentre the Chairman of the Governing Council shall cause a notice of vacancy to be published and, in consultation with the Governing Council, shall appoint a person to act temporarily as Director-General of the Centre.

EXCEPTIONS

7. The Governing Council may, if circumstances so warrant, waive the application of any of these rules by a two-thirds majority vote of the members present at a meeting.

AMENDMENTS

8. These rules may be amended at any time by a two-thirds majority vote of the members present at a meeting of the Governing Council.
