INTRODUCTION

- 1. The purpose of this document is to report on progress in the implementation of the programme of work and priorities for the biennium 1986-1987, during the first half of the biennium, as background for the examination of the proposals for the biennium 1988-1989. In this context, the report reviews implementation rates by programme, the problems experienced in implementation of mandated activities and examines implementation prospects during 1987 and for the entire biennium.
- 2. With the adoption by the General Assembly of resolution 37/234 on the Regulations Governing Programme Planning, the Programming Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation, an integrated management system is being gradually developed in the secretariat such that the previously separate activities are being steadily fused into an integrated whole. As for programme performance reporting, which is the subject of this report, there have been some improvements, although as observed by the Conference at its eighteenth session, much more remains to be done.
- 3. Changes in performance monitoring which have taken place since the last report to the Conference include the following:
- (a) The total number of mandated outputs against which performance is measured now includes outputs carried over from previous bienniums (following a decision of the Committee for Programme and Co-ordination):
- (b) All outputs reported as completed are now subject to auditing, and the Committee for Programme and Co-ordination has recommended that the General Assembly request the Board of External Auditors to include, in the Board's report to the Assembly, as appropriate, its findings with regard to the audits of output delivery carried out by the Internal Audit Division;
- (c) The assessment of performance by programmes is based on the number of outputs programmed for the biennium, including all outputs carried over from previous bienniums, and on that figure the performance rate is calculated using outputs implemented with or without reformulation;
- (d) Performance reports are now prepared on a six-month basis and the Executive Secretary makes a review of the implementation of the programme of work and priorities every six months to examine implementation problems and propose corrective measures.
- 4. The number and type of outputs to be implemented in each biennium are examined by this Conference and approved by the General Assembly on the recommendations of the Secretary-General of the United Nations to the Committee for Programme and Co-ordination which later recommends them to the General Assembly with or without

amendments. These outputs constitute the mandated outputs and provide the base upon which the monitoring exercise is based. As already indicated, the mandated outputs also include all outputs carried over from the previous bienniums.

- 5. On account of the grave financial situation facing the United Nations, the Secretary-General in early 1986 proposed, and the General Assembly approved, a number of measures to relieve the immediate cash situation of the Organization. The measures were carefully selected such that while affecting the implementation of mandated programmes, they would least prejudice them. Those measures included:
- (a) A 20 per cent reduction in costs relating to travel, the hiring of consultants, temporary assistance and overtime;
 - (b) The deferral of a number of alteration and maintenance projects;
- (c) Strict and rigorous application of the resolutions of the General Assembly and the Economic and Social Council on the control and limitation of documents.
- 6. In the course of the year, it became clear that the measures were not adequate, and new measures, with a direct impact on the implementation of mandated programmes were introduced. These included:
 - (a) Suspension of all recruitment;
- (b) Non-extension of appointments beyond retirement age for all staff at levels D-2 and below:
- (c) Deferral for a six-month period, of the implementation of the promotion register;
- (d) Further reduction of overtime allotments from the current 20 per cent to a total of 50 per cent;
- (e) A 30 per cent reduction in the number, duration and frequency of intergovernmental and expert group meetings.
- 7. The implementation of mandated outputs was severely affected as a result of these measures. Thus, advisory services, technical publications, and interpovernmental meetings were reformulated, postponed or terminated as a result of the crisis. Also since the incidence of vacancies differed from programme to programme, the implementation capabilities of programmes were similarly affected, and implementation rates vary quite widely as a result. For the secretariat as a whole 93 outputs were proposed for deferral by the Secretary-General in documents presented

to the resumed 40th session of the General Assembly, i.e. A/40/1101 (including its addenda and corrigenda) and A/C.5/40/CRP.4 hereafter abbies and 77 outputs were finally deferred. A further 82 outputs were either astroned or terminated because of the freeze on recruitment and the reduction in finite for consultancies, travel, intergovernment 1 and expert group meetings.

- 8. In determining the implementation rate presented for each programme, the number of deferred outputs has been excluded from the calculations since, as has been discussed above, resources for the implementation of those outputs were not available to the affected programmes. Since the same argument is also applicable to outputs postponed because of the freeze on recruitment, the reduction in funds for meetings, travel and consultancies and also to terminations arising from these factors, a second percentage implementation rate that excludes such outputs is presented in the text for all affected programmes.
- 9. For 1987, the financial situation still remains precarious, and most of the measures introduced in 1986 will continue throughout 1987. However, in order to distribute as equitably as possible the impact of suspension of recruitment on the implementation of mandated activities, the Secretary-General has now introduced, as a temporary measure, a vacancy management and staff redeployment plan which if successful should assist the secretariat in filling some of the existing vacant posts. But if the plan is not successful, the implementation of programmed mandates will continue to suffer and the number of postponed and terminated outputs may increase. The Conference may therefore wish, in consideration of the present situation to re-examine and decide on the future of all outputs described or postponed to 1987 because of the crisis.
- 10. The rest of this report is presented by programme, and for each programme, the review is made in to two sections:
 - (a) Summary of the implementation of mandated outputs during 1986;
- (b) Detailed examination of the departures from programmed commitments with reasons for such departures as appropriate.

- 16. Fifteen outputs were programmed for implementation during 1986. However, because of the finencial crisis facing the United Nations and the measures taken by the Secretary-General on the authority of the General Assembly like the freeze on recruitment, none of the outputs were implemented. DEVELOPMENT ISSUES AND POLICIES IN AFRICA

17. This programme has 8 subprogrammes and is managed by three secretariat units: Subprogrammes 1, 2 and 3 by the Socio-Economic Research and Planning Division (SERPD), subprogramme 4 by the Economic Co-operation Office (ECO), subprogrammes 5 and 6 by the Public Administration. Manpower and Management Division (PAMAD), and subprogrammes 7 and 8 by the Pan-African Development Information System (PADIS). Subprogrammes 7 and 8 are entirely extrabudgetary and have not been included in this report.

SUBPROGRAMMES: 1. SOCIO-ECONOMIC PLANNING

- 2. FISCAL, MONETARY AND FINANCIAL ISSUES AT THE NATIONAL LEVEL
- 3. LEAST DEVELOPED COUNTRIES
- 18. Twenty five outputs were programmed for implementation during 1986, and of those 17 were implemented as programmed and 1 after reformulation. Departures from programmed commitments included 7 outputs which were deferred because of the financial crisis. Two of the deferred outputs have been implemented in response to requests from two member States for technical assistance and support for the Round Tables and Donor Conferences organized by them, and another two have now been earmarked for termination. In addition, there were 4 additional outputs one of which was required by legislation and three added at the initiative of the secretariat.
- 19. Excluding 5 deferred outputs, the programme attained an implementation rate of 90.0 per cent during 1986.

SUBPROGRAMME: 4. POLICIES, INSTITUTIONS AND TECHNICAL ASSISTANCE FOR ECONOMIC CO-OPERATION

20. A total of 23 outputs were programmed for implementation during 1986, and of those 11 were implemented as programmed; 4 were deferred on account of the financial crisis; and 9 terminated for reasons other than the financial crisis. Thirty-seven additional outputs, required by legislation, were also prepared for the 5 MULPOC legislative organs.

21. Excluding deferred outputs, the subprogramme attained an implementation rate of 55.0 per cent on programmed commitments, rising to 82.8 per cent after adjusting for outputs prepared for the MULPOC legislative organs.

- 22. Progress already achieved in interregional TCDC/ECDC projects in priority areas renders outputs 4.1 (i) and (ii) obsolete, and they have consequently been terminated. Output 4.3 (ii) was also terminated as obsolete and of marginal usefulness. Resources released have been used in intermediate activities such as preparation of projects for the UNDP fourth programming cycle and completion of outputs for the first quarter, 1987.
 - 4.2 (v) Technical publication: Charter of collaboration among West African intergovernmental organizations (third quarter, 1986).
- 23. This output was terminated as it had already been published in 1984.
 - 4.3 (i) Advisory services to member States, on request, on (a) the evaluation of inter-subregional policies conducive to closer regional co-operation and integration (two missions in 1986); and (b) identification and formulation of inter-subregional projects and joint ventures for accelerating regional economic co-operation and integration through co-ordination and harmonization of the policies and programmes of the subregional economic groupings (two missions in 1986).
- 24. Both outputs 4.3(i) (a) and (b) were terminated because no member States had requested advisory services in those areas.
- SUBPROGRAMMES: 5. EDUCATION AND TRAINING FOR DEVELOPMENT
 6. MANPOVER AND EMPLOYMENT PLANNING AND POLICIES
- 25. A total of 30 outputs were programmed for 1936, and of those, 19 were implemented as programmed, and one after reformulation. Departures from programmed commitments included 5 outputs deferred because of the financial crisis and two postponed for reasons other than the financial crisis. Three outputs were terminated on account of the financial crisis.
- 26. Excluding the five deferred outputs, the two subprogrammes attained an implementation rate of 66.67 per cent on programmed commitments, rising to 86.36 per cent after adjusting for outputs terminated because of the financial crisis.

- 27. Since the Conference of Ministers Responsible for Human Resources Planning, Development and Utilization is scheduled to take place in October 1987, preparation of the report has been postponed to first half of 1987 so as to ensure an up-to-date presentation. The resources released from the postponement were used for organizing the ECA/IBRD Consultative Meeting on Strategies for the Development of Education in Sub-Saharan Africa.
 - 6.1 (ii) Substantive servicing of one national workshop for manpower and employment planners on concepts and techniques of manpower and employment plans and reports (one in 1986).

28. This output was postponed to 1987 following a request by the host member State that the workshop should be conducted in April 1987. Resources released from the postponement were used for preparing the Division's contribution to ECA's Survey of Economic and Social Conditions in Africa, 1985-1986.

(c) Terminated because of the financial crisis

- 6.2 (i) Advisory services to member States, on request, on developing a framework for manpower and employment planning data and information systems (one mission in 1986).
- 6.2 (iii) Technical publication on status and problems of manpower, and employment data collection and processing in selected member States (one in 1986).
- 29. Outputs (i) and (iii) above were terminated because of the non-availability of work-months following the retirement of a staff member at the end of June 1986 and the fact that no replacement took place on account of the freeze on recruitment due to the financial crisis.
 - 6.4 (i) Substantive servicing of the meeting of the Ministerial Follow-up Committee of Nine of the Conference of Ministers of Human Resources Planning, Development and Utilization (one in 1986).
- 30. This output was terminated by the secretariat because of the reduction in funds for intergovernmental meetings on account of the financial crisis.

ENVIRONMENT IN AFRICA

- 31. Eight outputs were programmed for implementation in 1986, and of those 4 were implemented as programmed, 1 after reformulation, and 1 was deferred on account of the financial crisis, 1 postboned because of the reduction of funds for expert group meetings and another for lack of requests. Other departures from programmed commitments included one additional output added at the initiative of the secretariat.
- 32. Excluding the deferred output, the programme attained an implementation rate of 71.4 per cent on programmed commitments rising to 83.3 per cent after excluding outputs postponed because of the crisis.

Subprogramme 3: Integration of women in development is managed by the African Training and Research Centre for Women (ATRCW). The implementation of the programme is therefore reviewed under that division of responsibilities.

SUEPROGRAMME 3: INTEGRATION OF MOMEN IN DEVELOPMENT

- 73. This subprogramme, which is managed by the African Training and Research Centre for Women (ATRCH) had a total of 24 outputs to implement during 1986. Of those outputs, 19 were implemented as programmed, and 1 was deferred because of the financial crisis. Other departures included 4 outputs which were postponed, one of which because of the freeze on recruitment and the reduction in travel and consultancy funds.
- 74 Excluding the one deferred output, the subprogramme attained an implementation rate of 82.6 per cent on programmed commitments rising to 86.4 per cent if the one output postponed because of the financial crisis is excluded.
