INTRODUCTION

- 1. The work programme for the biennium 1986-1987 contained in this document represents the second biennium programme of work and priorities to be prepared within the framework of the United Nations 1984-1989 (six-year) medium-term plan adopted by the General Assembly at its thirty-seventh session [supplement No. 6 (A/37/6)] and revised at its thirty-ninth session [supplement No. 6 (A/39/6)] in order to reflect legislative decisions and their programme implications since 1982 and to provide an up-to-date framework for the programme budgets for the second and third biennia of the six-year perspective.
- 2. The 1984-1989 medium-term plan covers only the activities which the United Nations itself proposes to undertake. It has been structured around specific objectives, and its various programmes and subprogrammes are designed to show the strategies that should be followed if those objectives are to be achieved within the resources available.
- 3. In common with the other units of the United Nations System, the United Nations (which includes the regional economic commissions) has used the International Development Strategy for the Third United Nations Development Decade and the policy measures established to achieve them as the basis for the preparations of the medium-term plan proposals. However, where sectoral and regional strategies exist, the regional commissions have complemented the proposals of the International Development Strategy with those of such sectoral and regional strategies. Thus, the Economic Commission for Africa has used the Lagos Plan of Action for the Implementation of the Monrovia Strategy for the Development of Africa, which incorporates the Final Act of Lagos, the African Regional Food Plan and the United Nations Transport and Communications Decade in Africa among other sectoral programmes and strategies in addition to the International Development Strategy as basis for preparing its own parts of the medium-term plan.
- 4. Thus in addition to the major issues raised in the International Development Strategy, the ECA parts of the medium-term plan emphasize among others the following:
- (a) Intensification of efforts to increase food production, to improve African agriculture and to develop agro-based industries, based on the regional food plan;
- (b) The development of transport and communications infrastructure so as to integrate the continent physically in accordance with the programme of the United Nations Transport and Communications Decade in Africa;
- (c) Industrial development focused on the use of domestic raw materials, now elaborated in the programme for the United Nations Industrial Development Decade in Africa;
- (d) Intensification of regional and subregional co-operation, through joint production activities and expanded African trade leading to the creation of an African common market by the year 1990 and an African Economic Community by the year 2000 as required by the Final Act of Lagos;

- (e) The special needs of African least developed countries which constitute the largest number of least developed countries of the world, in the context of the requirements of the Substantial New Programme of Action in favour of the least developed countries of the world adopted at the Paris Conference on the Least Developed Countries in 1981.
- The present biennium work programme and priorities comprise 16 programmes which are composed of 51 subprogrammes, 172 programme elements and over 2,000 final outputs. While programmes which derive directly from major programmes such as food and agriculture industrial development, etc., have invariably been designated on institutional basis, subprogrammes comprise identified groups of activities with distinct objectives within each programme. Programme elements and their corresponding intermediate activities and final outputs are the instruments designed for the achievement of those objectives.
- 6. In planning and programming language, final outputs are those goods and services which the secretariat intends to deliver during a specific biennium, to member States and their intergovernmental institutions either directly or through their representatives as measures for assisting them to solve their socioeconomic including technical problems. In the same context, intermediate acti-vities are those activities which, although directed at producing final outputs, will not lead to such final outputs during the particular biennium. Since what will interest member States are the final goods and services to be delivered to them, the emphasis in the document is on final outputs. However, since intermediate activities are found to be substantial, they have been included.
 - 7. In general, as part of the efforts to codify planning and programming activities in the United Nations, the following have been identified as final outputs:
 - (a) Substantive servicing of intergovernmental meetings, including support of negotiations; , and re¹ to sent out to all the

- 9. As already indicated, the proposals in this document have been based on the International Development Strategy as revised in 1984 and the Lagos Plan of Action including the Final Act of Lagos. However, in recognition of the changing environment within which all institutions function as clearly indicated by the present economic and social crisis confronting the continent, the secretariat has tried in many areas to propose measures which it believes the Commission should adopt in dealing with aspects of the crisis.
- 10. In various parts of the document, the symbol (XB) has been put against some intended outputs and activities. The symbol which means "extrabudgetary" is intended to indicate that the implementation of such outputs and activities will depend strictly on the availability of the extrabudgetary resources which the secretariat has either negotiated with donors or to which donors are expected to give their final approval during the biennium.
- 11. Similarly, with respect to programme elements, the phrases "highest priority" and "lowest priority" are used in the text. This designation has been applied strictly in accordance with the instruction of the General Assembly to the secretariat to designate "programme elements" with respect to 20 per cent of the resources which are likely to be available to any programme on the understanding that "highest priority" will apply to 10 per cent and "lowest priority" to 10 per cent. In effect, each programme manager is allowed to distribute 80 per cent of the resources available to him/her in accordance with his own perception, while the General Assembly, through recommendations from its appropriate subsidiary body, namely the Committee for Programme Co-ordination, reserves the right to determine the use of the 20 per cent on the indications given by the programme manager. In this context, the General Assembly may decide that the resources earmarked for programme elements designated "lowest priority" should be used to implement other activities of high priority including those already designated as such and that the "lowest priority" programme elements should be terminated. It may also provide more resources for those designated "highest prioroty".

- 12. It will be observed that with respect to each programme, the phrase "in Africa" has been added. The purpose of this addition is to distinguish ECA work programme and priorities from those of the other entities in the system since such entities have their own programmes for Africa.
- 13. Finally, it needs to be emphasized that the proposals contained in this document are yet to be discussed by the Committee for Programme Co-ordination at its twenty-fifth session to be held in New York in April/May 1985 when recommendations will be made to the General Assembly at its fortieth session in September/ December 1985 through the Economic and Social Council at its 1985 Summer Session. Since the Conference of Ministers does not deal with the allocation of resources, the purpose of submitting the document to its present meeting is to enable it as a regional programme-formulating organ to make its comments and proposals for consideration by the Committee for Programme Co-ordination.
